Introduction

Welcome to The thecentaurus.io website, owned and operated by EEE Capital Ventures, Inc. d/b/a thecentaurus.io ("thecentaurus.io," "we," "us" or "our"). These Terms of Use (these "Terms") govern your access to and use of the Centaurus website; including without limitation the creation, purchase, sale, exchange, mint or modification of certain digital assets; our online and/or mobile services, and software provided on or in connection with those services (collectively, the "Service").

This Service also allows you to sell and purchase Crypto Assets (as defined below) via auction ("Auction"). Detailed rules regarding the Auction process are available on this page, <u>Auctor Rules</u>. You may only participate in the Auction by linking your digital wallets on supported bridge extensions such as MetaMask (<u>https://metamesicio/</u>). MetaMask is an electronic wallet, which allows you to purchase, store, and engage in transactions using Ethereum cryptocurrency. Before putting up your unique digital asset for Auction or putting in an offer to purchase a unique digital asset from another user, we will ask you to download a supported electronic wallet extension and connect and unlock your digital wallets with that extension. Once you submit an order to sell or purchase a unique digital asset, your order is passed on to the applicable extension, which completes the transaction on your behalf.

"Crypto Assets" refers to unique non-fungible tokens, implemented on the Ethereum blockchain (the "Ethereum Platform") using smart contracts, including without limitation Eth Moji, Crypto Kitties, Crypto Celebrities, and Crypto Punks. ALL TRANSACTIONS INITIATED THROUGH OUR SERVICE ARE FACILITATED AND RUN BY THIRD-PARTY ELECTRONIC WALLET EXTENSIONS, AND BY USING OUR SERVICES YOU AGREE THAT YOU ARE GOVERNED BY THE TERMS OF SERVICE AND PRIVACY POLICY FOR THE APPLICABLE EXTENSIONS. FOR METAMASK, THOSE TERMS ARE AVAILABLE AT (<u>https://metamasicio/terms.html</u>) AND (<u>https://metamasicio/terms.html</u>)

Platform Fees

- 1. NFT Minting Fee:
 - A **1% platform fee** is applied to the total value of every NFT minted on The Centaurus. This fee is automatically deducted during the minting process and is non-refundable.
- 2. NFT Resale Fee:
 - A 1% platform fee is applied to the total resale value of every NFT traded on The Centaurus marketplace. This fee is automatically deducted from the sale proceeds upon transaction completion.

These fees are implemented to support platform development, security, and operational costs, ensuring a seamless experience for all users.

Note:

- The fees listed above are subject to change at the discretion of The Centaurus. Users will be notified of any fee adjustments via official communication channels.
- Additional blockchain network fees (e.g., gas fees) may apply based on the blockchain used for minting or trading. These are separate from The Centaurus platform fees and are determined by the respective blockchain protocols.

2. Account Registration and Communication Preferences

- a. If you wish to participate in an Auction for Crypto Assets, you will need to register for an account on the Service ("Account").
